We developed custom technical training materials for classroom and electronic (desktop) delivery, proofed and edited documentation prepared by Intel staff, prepared PowerPoint presentations for management to deliver, and developed several workshops which were handed off to Intel University.

A word about training and documentation projects

I must own having some biases when it comes to the methods to be used for conveying information. I tend to use specific methods not only because I know them, but because I've followed the research, and I know they work!

Documentation:

What you are seeing here is an applied example of the method taught in the Information Mapping® courses. The idea is to break the information into chunks, or "blocks," according to type, and provide labels that guide the user through the document and act as reference points. It does not have to look exactly like this, but whatever the format the idea remains basically the same.

A word about training and documentation projects, cont'd.

Training:

Effective training can be implemented by providing learners not only with hands-on or simulated practice, but even more importantly by including reference materials they can go back to later—i.e., the training is “reference-based.” Reference-based training, or RBT, has been shown with post-training performance tests to outperform traditional instructor led classroom training by a wide margin. The reference can be provided in the form of paper-based manuals or provided directly to the desktop in the form of electronic help files, tutorials or web pages.

Web page authoring

Web work is a somewhat different animal. Users are able to interact with the content displayed on web pages in a very different way than with hard copy documentation, and the writing techniques and development process differ accordingly.

Development tools

Most writers and developers use a fairly standard tool set, and I claim no special distinction here, except that I generally know the software tools very well, and probably better than most. Software tools and coding sets that I use frequently include:

- MS Office suite
 - ▶ document development with InfoMap™ template
 - ▶ spreadsheet design with Excel
 - ▶ database creation with Access
 - ▶ presentation development with PowerPoint
- Corel Graphics studio
 - ▶ vector graphics creation with CorelDraw
 - ▶ raster/bitmap editing with PhotoPaint
 - ▶ animations and special effects with R.A.V.E.
- SWISH
 - ▶ Flash building and editing
- GIF Construction Set Pro and IconForge
 - ▶ GIF creation and editing
 - ▶ icon building and editing
- VIM
 - ▶ a highly configurable text editor useful for editing code
- HTML
 - ▶ the standard for web work
- PHP
 - ▶ coding used for bulletin board and forum software and for storefront and shopping cart solutions, among other uses
- MySQL
 - ▶ billed as "world's most popular open source database"

Naturally, I have at least a nodding acquaintance with a long list of others, and am able to obtain and learn new/other tools according to project requirements.
